Membership Typologies¹

Full Members (Regular)

- Members who participate to the activities of the Association and pay the annual membership fee determined by the INSME Board.

Sustaining (Gold) Members

- Members who sustain the Association in its total or partial activities through the donation of an annual fee higher than the ordinary one established in accordance with the INSME Board.

Honorary Members

- This type of membership is awarded to International Intergovernmental Organisations, who are distinguished, nationally or internationally, for carrying out activities closely connected or complementary to the objectives of the Association. The selection of candidates among appropriate entities and their appointment for this high honour is the competence of the Board.

Observer Members

- An observership can be granted only once and for one calendar year per organization; after this period of approaching the network and its activities, the candidates may decide whether to resign or become full members.

¹All fees are considered to be paid per calendar year. As foreseen by the Statute after September 30th, the fee covers also the upcoming year.

Full Members

- 4 free passes for the INSME Training (in occasion of the Annual Meeting), 50% discount for further participants
